Pursuant to the provisions of Article 607.1006 of the Florida Statutes, the undersigned Florida Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

ARTICLE I

The name of the corporation is COLDfire Technology, Inc. The document number issued to the corporation by the secretary of state is P00000065667.

ARTICLE II

The amendment changes the articles of incorporation to change the article that names the corporation. Article One in the Articles of Incorporation is amended in its entirety to read as follows:

ARTICLE III


