## **MONEY BOARD CORP.**

THE UNDERSIGNED subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

### **ARTICLE I. NAME**

THE NAME of this Corporation is: MONEY BOARD CORP.

### **ARTICLE II. NATURE**

THE GENERAL NATURE of the business to be transacted by this Corporation shall be:  
Real estate rentals, investments and management.

- A. To engage in every aspect and phase of the business of operating a computer equipment and software wholesale, retail and export business.

To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and in all other States and Countries.

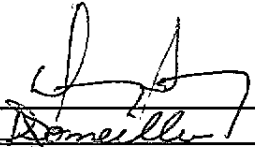
