We, the undersigned, ROBERT JOSEPH SCHLOCKER and ROBERTA LEE SCHLOCKER, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.

- NAME. The name of the corporation shall be NauticAid,
