

FOURTH ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CSC UNION SQUARE GP CORPORATION



Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Fourth Articles of Amendment to its Articles of incorporation (the "Fourth Amendment"):

FIRST: The name of the corporation is CSC Union Square GP Corporation (the "Corporation").

SECOND: The following amendment to the Articles of Incorporation was adopted by a majority of the Stockholders of the Corporation (the number of votes cast being sufficient for approval) and the Directors of the Corporation by a Written Consent of Directors in Lieu of a Special Meeting dated as of June <u>27</u>, 2003, and a Written Consent of the Holders of a Majority of Common Stock of the Corporation in Lieu of a Special Meeting, dated as of June <u>27</u>, 2003, in the manner prescribed by Sections 607.1003 and 607.1006 of the Florida Business Corporation Act:

Subparagraph (i) of Paragraph 1 of ARTICLE X of the Second Articles of Amendment to the Articles of Incorporation of the Corporation filed with the Florida Department of State on May 31, 2002 (the "Second Amendment") is hereby amended in its entirety to read as follows:

"(i) Except as permitted by KeyBank National Association, as Administrative Agent or its successors or assigns (collectively, the "Lender"), the Corporation shall not guarantee or assume or hold itself out or permit itself to be held out as having guaranteed or assumed any liabilities or obligations of any Affiliate, nor shall it make any loan to any Affiliate, except it shall be obligated under loans to CSC Union Square, Ltd., a Florida limited partnership (the "Partnership"), of which it serves as the General Partner."

THIRD: Except as hereby amended, the Articles of Incorporation of the Corporation, as Amended by the First Amendment, the Second Amendment and by the Third Amendment, shall remain the same.
