

Ms. Bailey,

As per our conversation via telephone today, I am writing this letter requesting that The Lawnery of Tallahassee's incorporated status be reinstated and that the \$600.00 reinstatement fee be waived. The reason for my request is as follows: 1.) In the past 5 months we have had a financial strain due to customers not paying us; which almost forced us to shut down. 2.) We still have very old invoices owed to us outstanding along with many bills still owed as a result of those jobs and we do not have \$600.00 to pay. 3.) The returned check for the \$150.00 was an error on our part where we forgot to record another item that we had paid; however, with the financial strain caused by the lack of us getting paid, we were not even able to come up with the \$150.00 to replace the check to pay you until now. 4.) Over the last 4 months, business has also been real slow for us which that along with the fact that the few jobs that we were getting - we were not getting paid from - just enhanced the financial hardship. 5.) If you do not waive the \$600.00 penalty, we will be forced to shut down because I don't know when we would be able to afford paying \$600.00 with things the way they are now. Please reinstate our corporate status. I have enclosed a guaranteed bank check for \$150.00 for the filing fee plus the \$15.00 fee for the consideration of my request.
