ARTICLES OF INCORPORATION

SECHETARY LESTATE TALLAMASSEE, FLORIDA

OF

Metro FiberNet, Inc.

The undersigned, acting as incorporator of Metro FiberNet, Inc., (the "Corporation) under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation is: Metro FiberNet, Inc.

ARTICLE II

COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on the date of the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

ARTICLE III

DURATION

The duration of the Corporation shall be perpetual

ARTICLE IV

PURPOSE

The general purpose or purposes for which the corporation is organized is to transact any and all lawful business for which the Corporation may be incorporated under the Florida Business Corporation Act.

ARTICLE V

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE VI

AUTHORIZED SHARES

The Corporation is authorized to issue Ten Million (10,000,000) shares of Common Stock at \$.0001 par value. The Corporation is authorized to issue Two and a Half Million (2,500,000) shares of Preferred Stock at \$.0001 par value per share, in such series and variations in the relative rights and preferences, including voting rights, if any, between such series as the Board of Directors shall determine.

The Corporation shall reimburse each person for all costs and expense, including attorney's fees, reasonably incurred by him or her in connection with any such liability in the manor provided for by law or in accordance with the Corporation's Bylaws.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he or she may be lawfully entitled, nor shall anything therein contain of restrict the right of the Corporation to indemnify or reimburse such person in any proper case even though not specifically provided for herein.
