ARTICLES OF INCORPORATION

FOR

FORAN SURVEYING AND MAPPING, INC.



KNOW ALL MEN BY THESE PRESENTS: That the undersigned individual does hereby incorporate a corporation under the provision of Chapter 607, Florida Statues, for the transaction of business with and under the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be and is <u>FORAN SURVEYING AND</u> <u>MAPPING, INC</u>. located at 30908 Vistaview, Mount Dora, FI 32757.

ARTICLE II

The duration of the corporation shall be and is perpetual, and the date and time of commencement of the corporation's existence shall be and is <u>July 7, 2000</u>.

ARTICLE III

The general purposes for which the corporation is initially organized are as follows:

To provide a service of land surveying and mapping for residential and commercial land use.

To transact any or all business for which corporations may be incorporated under Chapter 607, Florida Statues.


