**KNOW ALL MEN BY THESE PRESENTS:** That the undersigned individual does hereby incorporate a corporation under the provision of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation shall be and is **FORAN SURVEYING AND MAPPING, INC.** located at 30908 Vistaview, Mount Dora, FL 32757.

**ARTICLE II**

The duration of the corporation shall be and is perpetual, and the date and time of commencement of the corporation's existence shall be and is **July 7, 2000.**

**ARTICLE III**

The general purposes for which the corporation is initially organized are as follows:

**To provide a service of land surveying and mapping for residential and commercial land use.**

**To transact any or all business for which corporations may be incorporated under Chapter 607, Florida Statutes.**

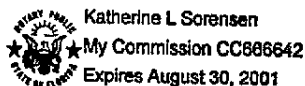
