ARTICLE I
NAME

The name of this corporation is: Insight Golf, Inc.

ARTICLE II
DURATION

This corporation shall exist on a perpetual basis commencing on the date of the signing of these Articles.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of engaging in the manufacture and sale of golf equipment and any and all other lawful businesses for which a corporation may be incorporated under the Florida General Corporation Act, Chapter 607, Florida Statutes.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock, said shares having a par value of One Dollar (\$1.00) per share.


