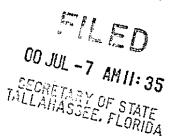

INC. 00 JUL -7 AM/1:36 The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation A hereby adopts the following Articles of Incorporation.

ARTICLE 1. NAME

The name of the Corporation shall be: J & M REFRIGERATION AND INSULATION, INC.

ARTICLE 2. PRINCIPAL OFFICE

The principal office and mailing address of this corporation Shall be: 1681 West 37th Street, Bay 22, Hialeah, Florida 33012.

ARTICLE 3. PURPOSE

This purpose for which the Corporation is organized is to engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE 4. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE 5. SHARES
