The name of the corporation is GCA Homes, Inc.

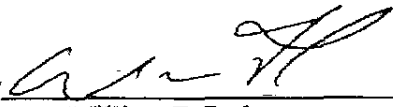
SECOND

The amendment was adopted by unanimous vote of the shareholders on November 17, 2005.

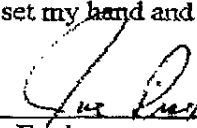

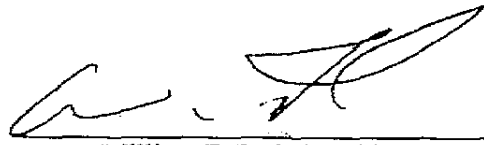
RESOLVED, that on November 17, 2005, the name of GCA Homes, Inc. is changed to GCA Home Team, Inc. And it is
