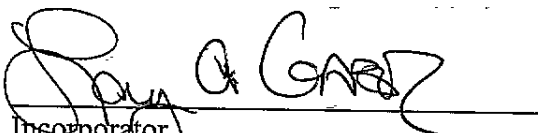

**ARTICLES OF INCORPORATION
FOR

For the purpose of forming a corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is LG MARKETING OF TAMPA BAY, INC.

ARTICLE II. DURATION

The duration of this corporation shall be perpetual.

ARTICLE III. PURPOSE

The purpose of this corporation shall be to consult for businesses, manage investments, and all other lawful business for which a corporation may be incorporated under the Florida General Corporation Act.

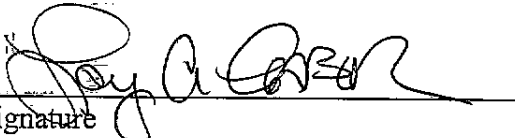

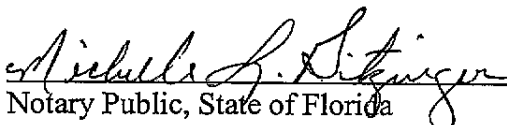

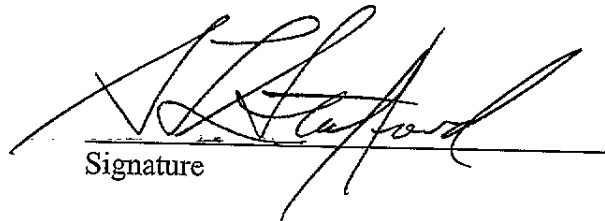
