ARTICLE I NAME

The name of this corporation shall be Centian Internet Services, Inc.

ARTICLE II DURATION

This corporation shall have perpetual existence.

ARTICLE III PURPOSE

This corporation is organized for the purpose of transacting of any and all lawful activities or business for which corporations may be incorporated under the Florida Business Corporation Act. The corporation shall have all powers permitted to a corporation under the Florida Business Corporation Act as enumerated in Florida Statute §607.0302 and §607.0303.

The corporation shall indemnify any Officers or Directors, or any former Officer or Director, to the fullest extent permitted by law.

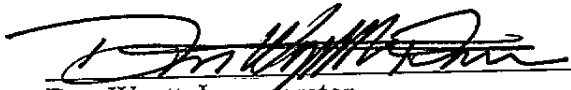
