ARTICLES OF INCORPORATION

OF

SELLED WINS The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.

NAME.

The name of this corporation is ALWAYS DEAL DIRECT, INC. The principle Place of business of this corporation shall be 16940 S.W. 78th Place Miami, Florida 33157.
