INCORPORATION
OF

BEFORE ME, the undersigned authority, this day personally appeared
Osvaldo J. Diaz who first by me being duly sworn deposes and says;

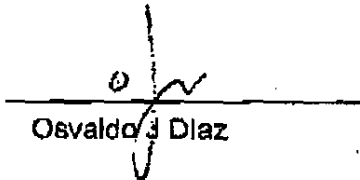
That pursuant to the provisions of section 607.1006, Florida Statutes, this
corporation adopts the following articles of amendment to its articles of Incorporation:

First: Be it amended that Article V of the original Article of Incorporation has
been changed to remove Osvaldo J. Diaz as Director of the company.

Second: That the corporations officer and directors are hereby changed and shall
hereafter be known as Americo Rosales Director of the company.

Third : The date of the change of officers shall be effective on the date filed in the
Office of the Secretary of State, Division of Corporations, State of Florida. This is
adopted the 4th day of August 2009.

Fourth: The officer and directors approved the amendment. The number of votes
