**ARTICLES OF AMENDMENT TO THE ARTICLES OF  
INCORPORATION OF

Pursuant to the provisions of FS § 607.1006, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is Mark S. Schecter, P.A.
2. The following amendments of the articles of incorporation were adopted by the sole shareholder and director of the corporation on November 20, 2001 in the manner prescribed by the Florida Business Corporation Act:
  - A. The name of the corporation shall be changed to: Schecter & Moore, P.A.
  - B. That the authorized shares of the corporation shall be increased by Four Thousand Nine Hundred, so that the authorized shares of the Corporation shall be Five Thousand Shares.
  - C. That the effective date for the amendments set forth in subsections 2A. & 2B. above shall be January 2, 2002.
3. The number of shares of the corporation outstanding at the time of adoption was one hundred (100); and the number of shares entitled to vote on the amendments was one hundred (100).
4. The number of shares voted for the amendments was one hundred (100); and the number of shares voted against the amendment was zero.
