The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is GENERAL SENSORS, INC. The principal place of business of this Corporation shall be 5711 Bayview Drive, Ft. Lauderdale, Florida, 33308, or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue 1,000,000 shares of common stock with a par value of one-tenth of a cent (\$.001) per share.

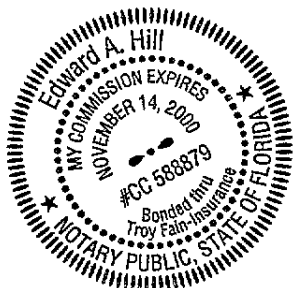
