**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is ADVANTAGE PRINTING AND PROMOTIONAL PRODUCTS, INC. and its principal office and mailing address is 11015-A North Dale Mabry Highway, Tampa, FL 33618

**ARTICLE II**

**Commencement of Corporate Existence**

The corporation shall come into existence on the date of filing with the Florida Secretary of State.

**ARTICLE III**

**General Nature of Business**

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.
