
ARTICLES OF INCORPORATION OF
PRO-ADT, INC.

EFFECTIVE DATE

7-6-00

1. Name. The name of the corporation is: PRO-ADT, INC.
2. Purpose. The corporation may engage in any legal business.
3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding 1,000 shares of common capital stock with no par value. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on the 6th day of July, 2000.
