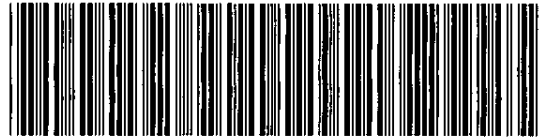




Consent to Action in Lieu of Meeting of Capital Funding Enterprises, Inc.


