ARTICLE I--NAME

The name of this corporation is D & S MOBILE MARINE,  
INCORPORATED and its principal place of business is  
2321 20th Avenue West, Bradenton, Florida, 34205.

ARTICLE II--DURATION

This corporation shall exist perpetually.

ARTICLE III--PURPOSE

This corporation is organized for the purpose of any  
and all lawful businesses for which corporations may be  
incorporated under the Florida General Corporation Act.

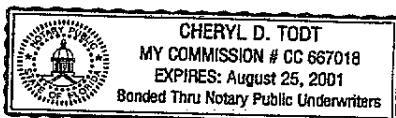




