Dear Concerned:

This letter is concerning the submission of the 2001 Uniform Business Report (UBR) for PRC Productions, Inc. This is the first year of the corporation and this letter serves as an explanation of why the UBR is late and to seek forgiveness of the late fee.

I never received the mailing of the 2001 UBR from your office. I believe this is due to an incorrect address being implemented into the computer database at your location. I have enclosed verification of an incorrect address in your database (Exhibit I) with a print out from sunbiz.org. This clearly shows an incorrect street (24 Street) being listed.

This has to be a mistake from the Department of State because I have also enclosed a copy of the original Articles of Incorporation (Exhibit II) which clearly show the correct street (26 Street). Furthermore, the Department of State had the correct address at one time as shown in the August 16, 2000 letter (Exhibit III) from Doris Brown in your office.

I do not know at what stage the mailing address for PRC Productions, Inc. was altered, but this change caused the 2001 UBR to be mailed to an incorrect address and is clearly the cause of PRC Productions, Inc.'s 2001 UBR to be late.

In light of this error on the part of the Department of State I request that my enclosed check for \$150 be accepted as payment in full for PRC Productions, Inc.'s 2001 UBR payment.

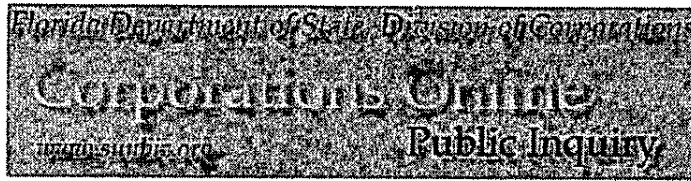
