The name of the corporations shall be **ANED ENTERPRISES INCORPORATED**

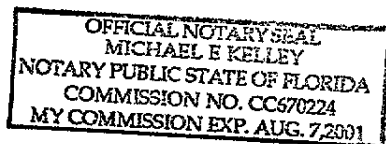
