**ARTICLES OF INCORPORATION
OF
RECJ, INC.**

ARTICLE I - NAME

The name of this corporation is: RECJ, INC.

ARTICLE II-DURATION

This corporation shall have a perpetual existence commencing on the date of signing of the Articles of Incorporation.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any/or all lawful Business as allowed under the laws of Florida and the United States of America.

ARTICLE IV-CAPITOL STOCK

This corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par Value common stock, which shall be designated "common shares".

ARTICLE V-PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI-STOCKHOLDER AND CORPORATION OPTION
TO PURCHASE STOCK**

In case a stockholder desires to sell his shares of stock he must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in the purchase of such shares, and any attempted sale in violation of this provision is null and void.

If none of the stockholders desire to purchase the shares of stock, the stockholder must then offer the corporation the option to purchase, it being the intention to give the corporation the second preference in the purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his stock shall file notice in writing of his intention with the secretary of the corporation, stating the terms of the sale, and unless his terms are accepted by any or all of the other stockholders within ten (10) days thereafter, then the corporation has five (5) days to exercise its option. If neither the shareholders nor the corporation exercise their option, then they shall be deemed to have waived their privilege of purchasing, and the stockholder will be at liberty to sell to anyone else.

ARTICLE VII-INITIAL PRINCIPAL OFFICE

The street address and mailing address of the initial principal office of this corporation is 43 SE Miracle Strip, Fort Walton Beach, FL. 32548 and mailing address is the same.

ARTICLE VIII- INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 58 Country Club Dr. Shalimar, Florida 32579 and the name of the initial registered agent of this corporation is Siegfried F. Kessler,

ARTICLE IX- INITIAL BOARD OF DIRECTORS

This corporation shall have (1) one director initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one. The name and address of the initial directors and officers of this corporation are:

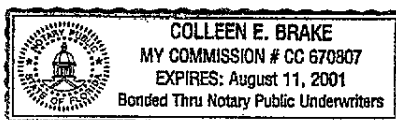

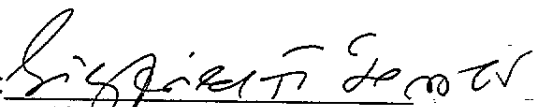

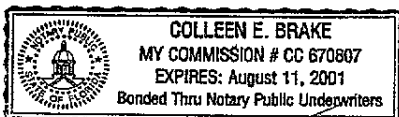
