

This letter is to serve as written confirmation of our conversation on April 10, 2002.

Sosa Holdings Inc. was dissolved erroneously. On April 26, 2001 check #8528 in the amount of \$150.00 was issued and sent together with the 2001 UBR. This check cleared our bank in May 2001. Shortly thereafter we received what would be considered a Second Notice with an additional fee of \$400.00 for late charges. We disregarded the second notice as we knew that payment had been sent and thought that the day of payment receipt and the mailing date of the Second Notice had overlapped in the mail.

Around mid-May the UBR was returned together with a note advising us it was missing the signature of the authorized agent. The form was immediately sent to our authorized agent and attorney for the missing signature and was then mailed back to the Division of Corporations.

Only in March 2002 did we realize the company had been dissolved and immediately to action to resolve the situation. As per your instructions enclosed is the completed Corporation Reinstatement Form together with check #10788 in the amount of \$150.00 for year 2002 and hereby request that the reinstatement fee be waived.
