

Per our phone conversation last week, the following is a brief explanation of how the confusion regarding the filing fee developed. The 2001 Uniform Business Report for Villaverde Development Corp. (formerly known as ARK Enterprises, Inc.) was submitted months ago with a check for \$150, which was cashed at that time. In the UBR the new name was used. The UBR was then sent back to me stating that I either file a UBR using the old name or submit a name change application. I had already sent the amendment application, with its fee, but I guess the mail crossed at some point in time.
