ARTICLES OF INCORPORATION  
OF

BATTERED WOMEN'S HOUSING FOUNDATION, INC.

ARTICLE I - NAME

The name of the corporation is BATTERED WOMEN'S HOUSING FOUNDATION, INC. hereinafter called the "Corporation")

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 6,000 shares of Common Stock.

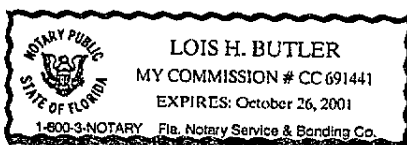


