

ARTICLES OF INCORPORATION  
OF  
KIRKPLAN KITCHEN AND BATH NAPLES, INC

ARTICLE I

Name. The name of this corporation is KIRKPLAN KITCHEN AND BATH  
NAPLES, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

Purpose.— This corporation is organized for the purpose of  
transacting any or all lawful business.

ARTICLE IV

Capital Stock. This corporation is authorized to issue 1,000  
shares of common stock at \$1.00 par value, which shall be designated  
"Common Shares".

Except as otherwise provided by law, the entire voting power for  
the election of directors and for all other purposes shall be vested  
exclusively in the holders of the outstanding Common Shares.

ARTICLE V

Preemptive Rights. Every shareholder, upon the sale for cash of  
any new stock of this corporation of the same kind, class or series as  
that which he already holds, shall have the right to purchase his pro  
rata share thereof (as nearly as may be done without issuance of  
fractional shares) at the price at which it is offered to others.

ARTICLE VI

Initial Principal Office. The street address of the initial principal office of this corporation is 3376 South Seclusion Drive, Sarasota, Florida 34239.

ARTICLE VII

Board of Directors. This corporation shall have no Directors or Officers initially. The affairs of the corporation will be managed by the shareholders until such time as Directors are designated as provided by the Bylaws.

ARTICLE VIII


ARTICLE XI
