I, the undersigned subscriber to these Articles of
Incorporation, natural person competent to contract, hereby form
a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

Paradise Resort Development Corporation

ARTICLE II

The general nature of the business to be transacted by this corporation is for commercial and residential real estate development, construction, management and investment. This corporation will also engage in any other activities or business permitted under the laws of the United States and the State of Florida.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, manage, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services, of every class, kind and description except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance

association, cooperative association, fraternal benefit society, state fair or exposition. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes or other evidences of indebtedness and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To produce corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of capital stack of, or any bonds, securities, or other evidences or indebtedness created by other corporations of the State of Florida, or any other state government, and while owner of such stack to exercise all the rights, powers and privileges or ownership, including the right to vote such stock.

ARTICLE III

Stock

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is:

- 20,000 shares of preferred and/or common stock at sixty (\$.60) par value with_pre-emptive rights.
- A. Shareholders of the corporation shall have preemptive rights to acquire their pro rata share if stock of the corporation for all issues of the one class if common stock of the corporation no matter when authorized, and for whatever

Directors

The business affairs of the corporation shall be a

President, one or more Vice-Presidents, a Secretary, and a

Treasurer elected by shareholders as provided by the By-laws of the corporation. The shareholders may designate in the By-Laws for the delegation of the office of the Vice-President.

ARTICLE VII
