I recently discovered that my corporation had been Administratively Dissolved for non-payment of the annual fee.

I was not aware of any renewal fee that had to be paid, so I asked my accountant. He explained to me that I should have paid the annual renewal fee (of \$150.00) on or before May 1, 2001 and May 1, 2002 to keep my corporation active in your system. He explained that I should have received an original Uniform Business Report from your office in January or February each year. He explained to me what it looked like.

I do not recall ever receiving such a form from your office for any year. I guess that, because I did not renew for the 2001 year, your office never sent me a UBR form for 2002. So I never received a form for either year.

I respectfully request that you waive the reinstatement fees for both years 2001 and 2002, based on the fact that I did not receive your original forms.

I have completed the reinstatement application and enclosed it, and a check in the amount of \$300.00 (\$150.00 for each year of 2001 and 2002), with this letter.
