ARTICLE I  
NAME

The name of the corporation shall be Wilky Pool Service, Inc.

ARTICLE II  
PRINCIPAL OFFICE

The principal place of business/ mailing address of the corporation is 2136 N.E.  
27<sup>th</sup> Court, Lighthouse Point, Florida 33064.

ARTICLE III  
PURPOSE

The corporation shall have the power to engage in any lawful activity for which  
corporations may be organized under Florida law.

ARTICLE IV  
SHARES OF STOCK

The aggregate number of shares that the corporation shall have authority to issue  
and to have outstanding at any one time is 100 shares. All such shares shall be of a single  
class, designated as common.

Each holder of common shares shall have one vote for each such share held of record on all matters submitted for shareholder approval. Except as otherwise specifically required by law, or except as specifically provided in these articles of incorporation, all other matters requiring shareholder approval shall require an affirmative vote of a majority of the shares voting thereon. The holders of the common shares shall have unlimited voting rights and the right to receive the net assets of the corporation upon its dissolution.

No shareholder shall have the preferential or preemptive right to subscribe for or to purchase any shares of any class, any rights, warrants, or options with respect thereto, or any obligation convertible into or exchangeable for any such shares or other securities whether out of unissued shares or other securities or out of shares or other securities acquired by the corporation after the issue thereof, regardless of the consideration therefor.

The bylaws of the corporation may be amended by majority vote of either the directors or the shareholders.

The business of the corporation shall be managed by the shareholders without a board of directors.
