ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TRUCK REPAIR 1, INC., and the principal address and principal place of business is 1258 LORNEWOOD DRIVE, VALRICO, FLORIDA 33594.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL & O'CONNOR, P.A., 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is PATRICK M. O'CONNOR, ESQUIRE.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

ARTICLE IV - AUTHORIZED SHARES OF STOCK

The total number of shares of stock which the corporation is authorized to issue is Ten Thousand (10,000) of the Common Voting Class "A" shares with a par value of each of such shares to be designated as One Cent (\$0.01) amounting in the aggregate to One Hundred Dollars (\$100.00), and Ten Thousand (10,000) of Common Non-Voting Class "B" shares with a par value of each of such shares to be designated as One Cent (\$0.01) amounting in the aggregate to One Hundred dollars (\$100.00). Both Class "A" Voting and Class "B" Non-Voting shall share equally in the distributions or dividends with respect to the Corporation.

ARTICLE V - BOARD OF DIRECTORS

The business and affairs of the corporation shall be managed by the board of directors, and the directors need not be elected by ballot unless required by the bylaws of the corporation. The names and mailing addresses of each person who is to initially serve as a director until the first annual meeting of the stockholders or until a successor is elected and qualified, are as follows:
