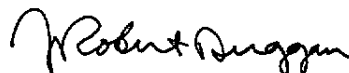

ARTICLE I. NAME

NAME: The name of this corporation is C & W FRAMING, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 14th day
of July, 2000.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of framing and construction work in
residential and commercial structures and transacting any and all other lawful business in
the State of Florida and the United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common
stock.

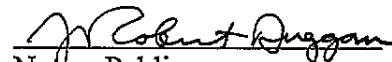
