To Whom it May Concern:

This letter is to apply for reinstatement of Captain Morgan's Dive Tours to conduct business in the State of Florida, and to have the reinstatement fee waived.

On 4-10-01 my corporation, Captain Morgan's Dive Tours, Inc. submitted a corporation report along with a check for \$150.00 to the Department of State as required. I heard nothing back from the State, received no notice that there was any problem with the report, and my check was promptly deposited.

I suspect that the reason I received no notice that there was a problem with the report was that my company's mailing address on your paperwork was incorrect. The Post Office in Key Colony Beach will not deliver mail without a Post Office Box number, and your correspondence had a street address only. Whether or not I receive mail directed to the street address depends largely on which clerk is working at the time the mail comes through. If he/she happens to know that Captain Morgan's Dive Tours uses PO Box 510299, I get the mail. If not, I will not receive it.

I have since changed the mailing address and have indicated the new location on the reinstatement application. I hope that this explanation will be sufficient to have the reinstatement fee waived, and allow me to continue to conduct business.

To be frank, I find it upsetting that the state would go ahead and cash my check, then revoke my license to conduct business without making any further effort to contact me about a problem with a report that I took the time to submit and pay for. I am sure that the notices you sent were returned as undeliverable. A registered letter would have prompted the Post Office to notify me to respond and sign for the letter. My telephone number must be on file somewhere in the Department of State or the Department of Revenue where I send my sales tax each month. If all else failed, it is printed on the check that the State was so eager to cash.
