LIMITATION OF LIABILITY

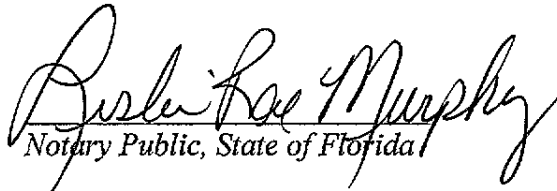
