The undersigned, acting as the incorporator of this Corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE I: NAME OF CORPORATION

The name of the corporation is PERIODONTICS & IMPLANTOLOGY OF PEMBROKE PINES, INC.

ARTICLE II: MAILING ADDRESS OF THE CORPORATION

The mailing address of the Corporation is at 2213 N. University Drive, Pembroke Pines, Florida 33024.

ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSE OF THE CORPORATION

The purposes of the Corporation is organized to engage in the practice of dentistry, periodontics & implantology for which corporations may be incorporated under Chapter 607, Florida Statutes, as amended.

ARTICLE VII: INITIAL REGISTERED OFFICE AND REGISTERED AGENT

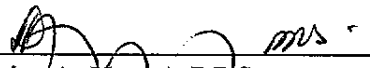

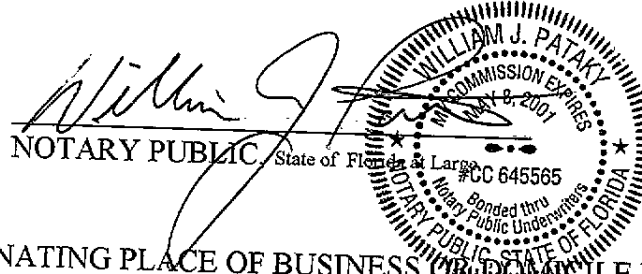

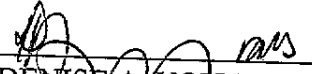
