**ARTICLES OF INCORPORATION  
OF  
RA NEWMAN TRUCKING, INC.**

The undersigned subscribes to the articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of this corporation is: RA NEWMAN TRUCKING, INC.

**ARTICLE II**

**NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is: To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, kind, and description; exception that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, fraternal benefit society, state fair or exposition.

**ARTICLE III**

**CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is seventy-five thousand (75,000) shares with par value of five dollar (\$1.00) each; a total of seventy-five thousand (\$75,000).

**ARTICLE IV**

**INITIAL CAPITAL**

The amount of capital with which this corporation will begin business is Seventy-five Thousand Dollars (\$75,000).

**ARTICLE V**  
**TERM OF EXISTENCE**

This corporation is to exit perpetually.

**ARTICLE VI**  
**ADDRESS**

The initial post office address of the principal office of this corporation in the State of Florida is 4433 Bass Street, Tampa, Florida 33617. The board of Directors may from time to time move the principal office to any other address in the State of Florida.

**ARTICLE VII**  
**DIRECTORS**

This corporation shall have one director, initially. The number of directors may be increased or diminished from time to time by laws adopted by the stockholders, but shall never be less than one.

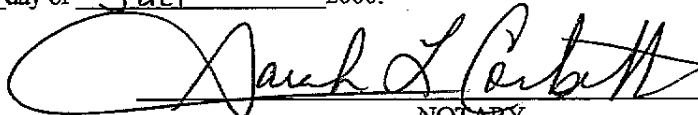

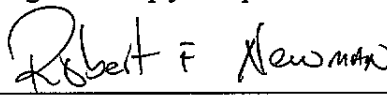
