#### **Article X Chapter "S"**

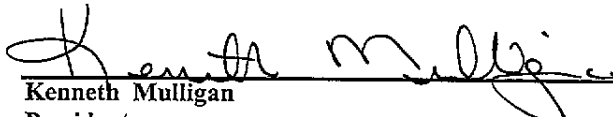
