**ARTICLE I**

**NAME AND ADDRESS**

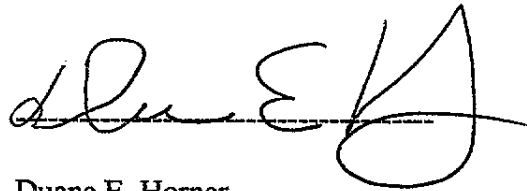
