The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, Florida Statutes, Section 607 and 621, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is: **Johnson Family Practice, P.A.**

ARTICLE II - DURATION

The existence of this corporation shall commence with the filing of these articles. The term of existence of this corporation is perpetual.

ARTICLE III - PURPOSE

The specific nature of business of the professional association, and the purpose of purposes of the professional association, purpose is to engage in the business of providing professional medical services, and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country, and to transact any or all other lawful business for which corporation may be incorporated under the Florida laws.
