ARTICLES OF INCORPORATION

OF

e-Doc Consulting, Inc.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, form a corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation shall be e-Doc Consulting, Inc.

ARTICLE II

The corporation may do all acts and things included in all or any of the general powers given private corporations for profit under the laws of the State of Florida.

The name and street address of the subscriber of these Articles of Incorporation Thomas C. Murphy and 208 32nd Street NW, Bradenton, FL 34205.


ARTICLE X


