ARTICLES OF INCORPORATION

OF

INTEGRATED MARKETING COMMUNICATION CONSULTORES CORP.

ARTICLE I- NAME

The name of the corporation is Integrated Marketing Communication Consultores Corp. (hereinafter called the "Corporation").

ARTICLE II- PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.
