

ARTICLES OF INCORPORATION  
OF

ARTICLE ONE

The name of the corporation is SUNSHINE HOMES OF WEST FLORIDA, INC.

The period of its duration is perpetual. The effective date is July 15, 2000.





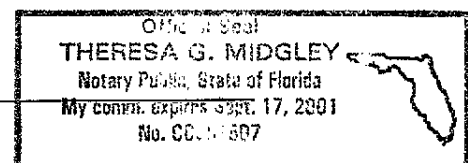
