ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of this corporation is RANDALL G. MINOR, P.A., and the principal address is 2414 University Boulevard West, Jacksonville, Florida 32217.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended. The primary business will be attorney at law.

ARTICLE IV - CAPITAL STOCK


ARTICLE X - INDEMNIFICATION
