ARTICLE ONE

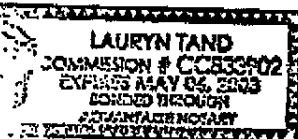

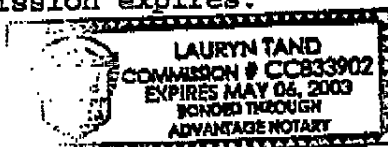
