**ARTICLES OF INCORPORATION**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is **The Tropical Reef Lobster & Seafood Restaurant, Inc.**

**ARTICLE II**

The existence of the Corporation shall begin immediately and its duration shall be perpetual.

**ARTICLE III**

The initial street address of the principal office of the Corporation is 8050 Trail Boulevard - Suite A, Naples, Florida 34108, or as may later be changed by the Board of Directors.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 7,500.
