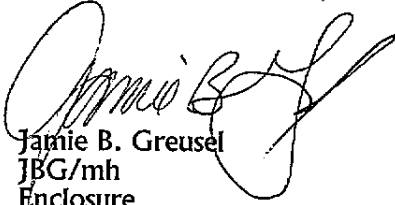

ARTICLES OF INCORPORATION
OF

I. NAME

X. AMENDMENTS

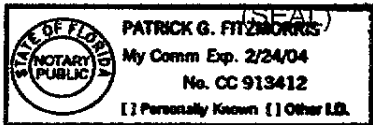


