

The name of the corporation is **COASTAL PLANNING COLLABORATIVE, INC.**

**SECOND:**

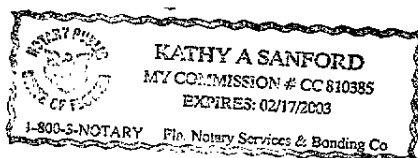
