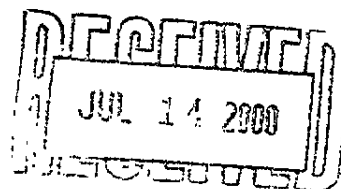

ARTICLE I. NAME

The name of this corporation is Sasha & Tango Capital, Inc.

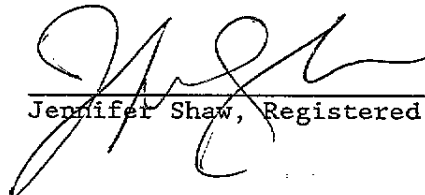
