

### ARTICLE I. NAME

following Articles of Incorporation.

The name of the corporation is CONNECT THE BYTES SOFTWARE,

The principal place of business of this corporation shall be 4340 A Fortune Place, West Melbourne, Florida 32904.

#### ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

#### ARTICLE III. CAPITAL STOCK
